

RULES OF REGISTRATION

FOR CATS ALREADY REGISTERED WITH ANOTHER ASSOCIATION (i.e. TICA, CFA, ACFA, CFF, ACA, etc.)

1. Proof of registration. Send photocopy of current registration.
2. Three (3) generation pedigree. Five generation pedigrees are requested if available. You may attach a copy of an existing pedigree rather than writing it onto the form.
3. Color photos showing front and all over side views of both sides of cat. Cat should be standing, not sitting, in side views. (Photos to become property of TCCI). The cat should be at least 9 months old when the photos are taken.
4. Payment of registration fee. \$7.00 (20% discount for Seniors)

FOR CATS NOT REGISTERED WITH ANOTHER ASSOCIATION, TO BE REGISTERED WITH TCCI AS FOUNDATION STOCK**

1. Must prove lineage, to include signed affidavit showing cat's date of birth, age, color, sex, as well as same information on cat's Sire and Dam (if available).

A signed veterinary certificate must be submitted on cats whose age is unknown, giving approximate age as well as confirmation concerning whether the cat has been altered.

2. Color photos showing front and all over side views of both sides of cat. Cat should be standing, not sitting, in side views, so that legs, feet, and tail are clearly visible. (Photos to become property of TCCI. The cat should be at least 9 months old when the photos are taken.
3. Payment of registration fee. \$7.00 (20% discount for Seniors)
4. Any pedigree information available on cat, Sire, or Dam.

**Foundation Stock acceptance will be reviewed by the GENETICS COMMITTEE within thirty (30) days of application. Those applications that are accepted will receive registration certificates. Those that are denied will receive a written explanation as well as a full refund of any fees paid.
